

DECISION NO. 19

Pursuant to paragraph 2(a) of the Understanding Regarding the Establishment of a Secretariat for Environmental Matters Under the Dominican Republic-Central America United States Free Trade Agreement (CAFTA-DR) and Article 4.3 of the Agreement Establishing a Secretariat for Environmental Matters Under the Dominican Republic-Central America-United States Free Trade Agreement (Secretariat Agreement), the Environmental Affairs Council established under Article 17.5 of the CAFTA-DR,

To appoint Mr. Mario René Mancilla Barillas, citizen of the Republic of Guatemala, to serve as the Technical Assistant of the Secretariat for Environmental Matters for an additional two-year term, starting on February 1, 2019, ending on February 1, 2021, with an opportunity to be appointed for additional successive terms if the Council so decides.

Pursuant to Article 4.3 of the Secretariat Agreement, the Council may, at any time, decide to remove the General Coordinator for cause or other appropriate reason.
